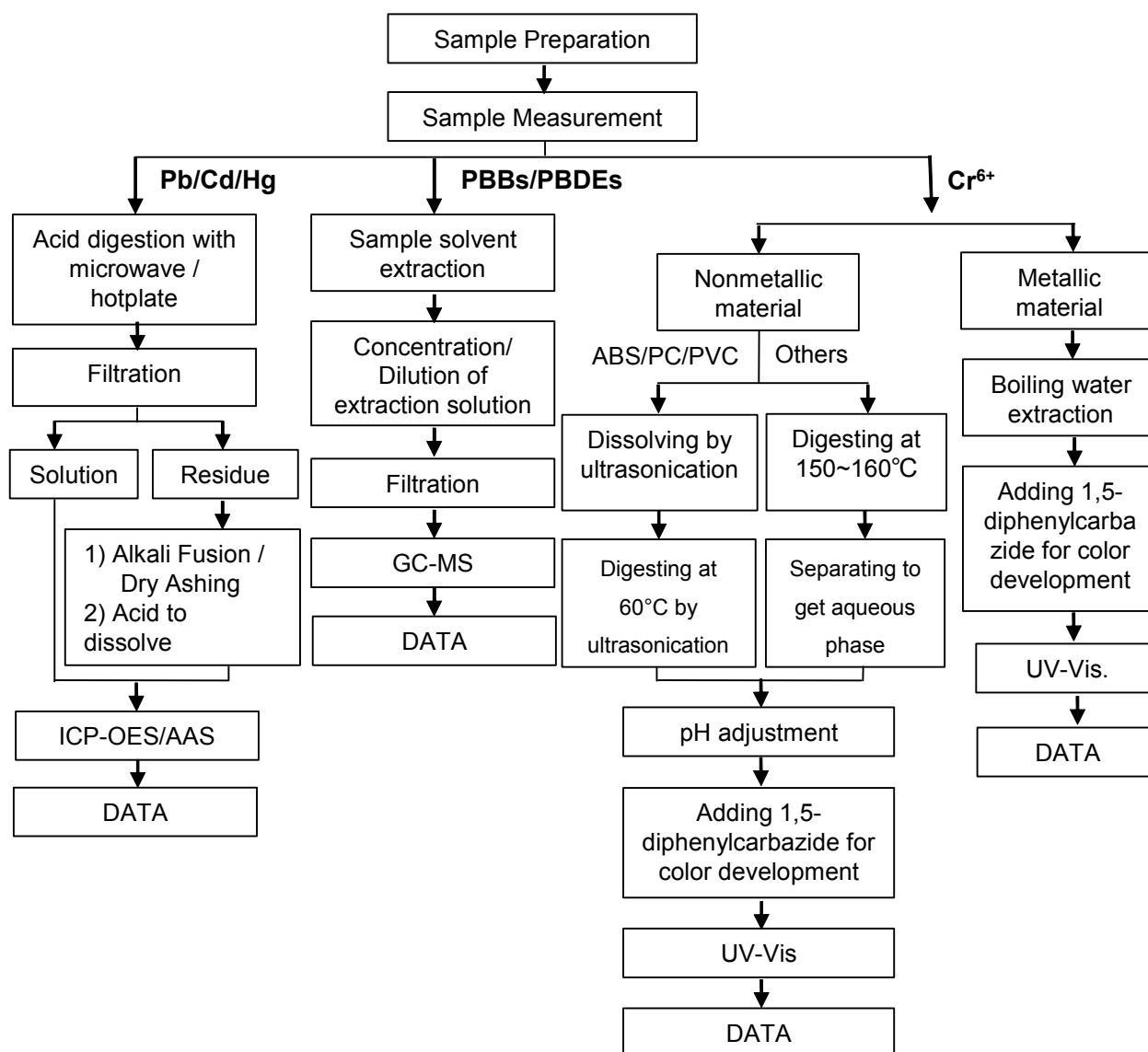

Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs Testing Flow Chart

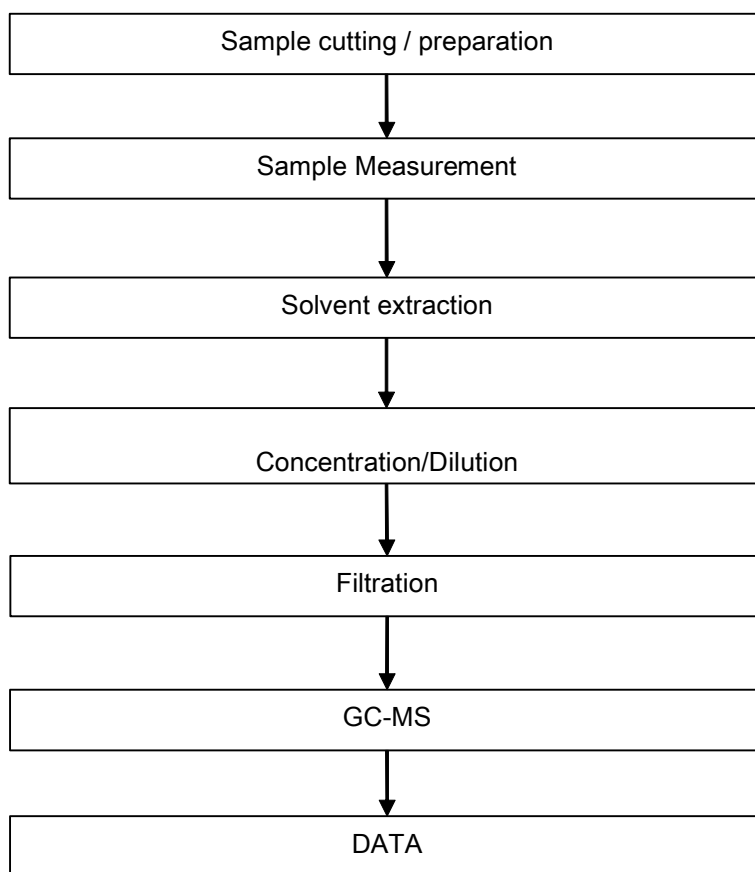

Phthalates Testing Flow Chart

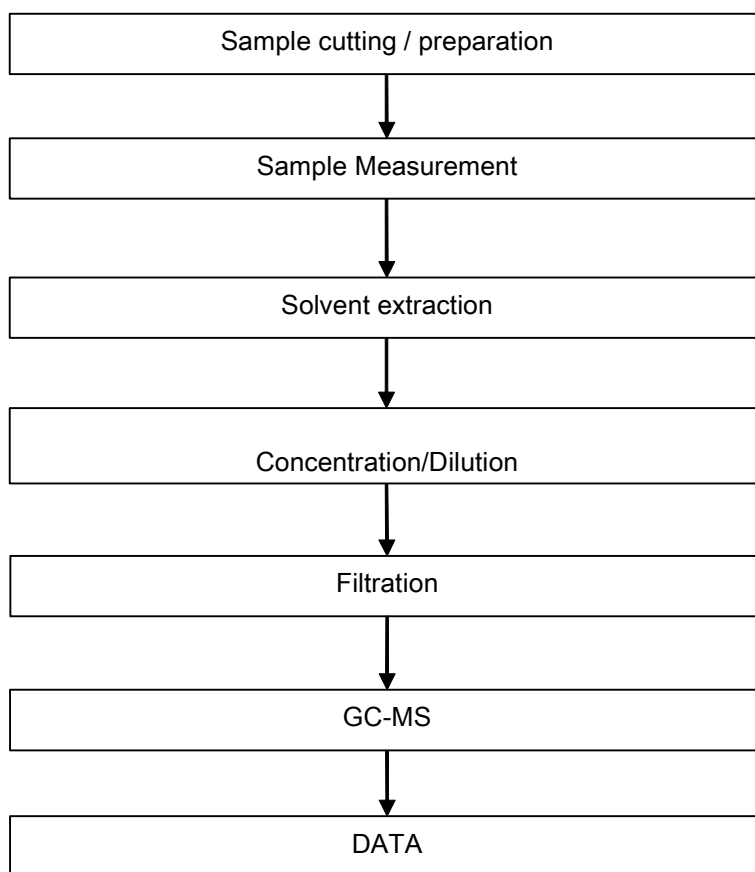

PAHs Testing Flow Chart

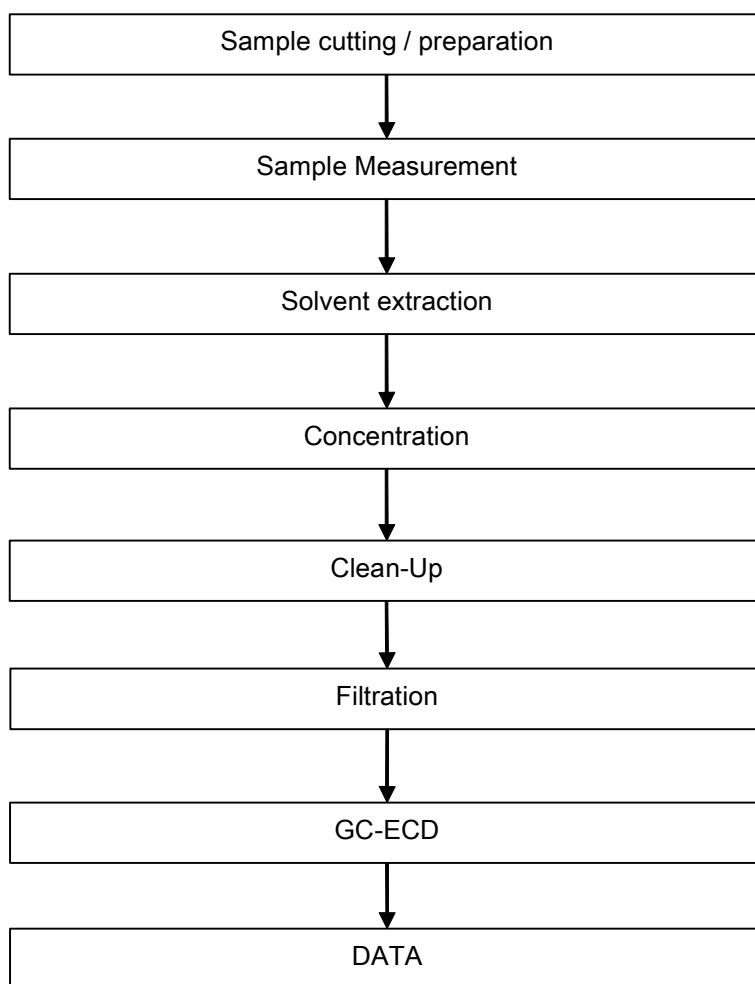

SCCP/MCCP Testing Flow Chart

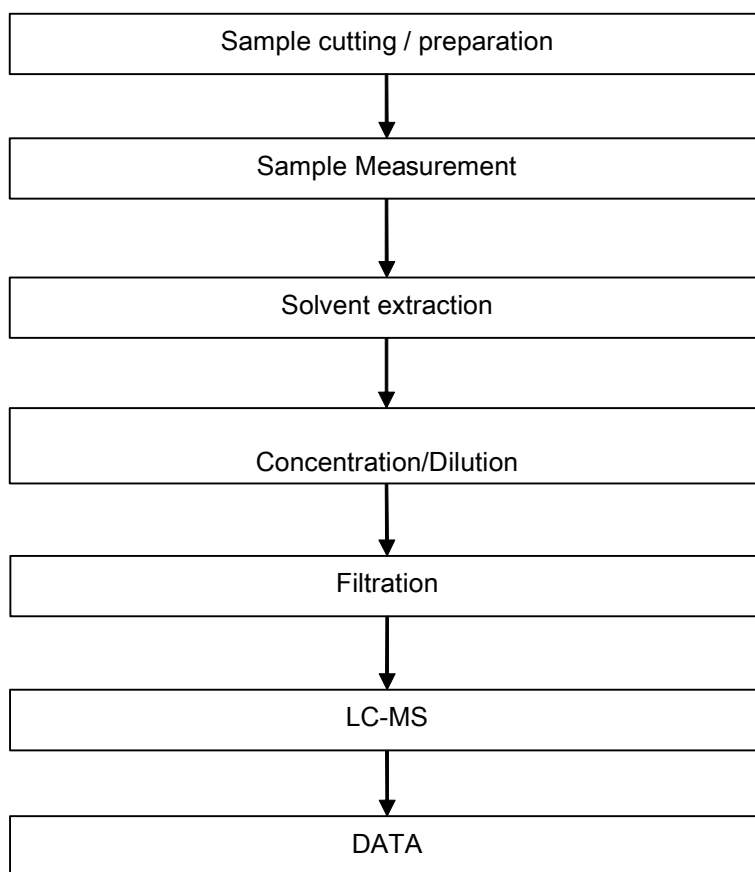
